## **1. PURPOSE**

The Saham Toney Parish Heritage Asset Register forms part of Policy 6 of the Saham Toney Neighbourhood Development Plan, and is to be read in conjunction with that Policy. The Asset Register defines those buildings, and archaeological and historical sites and finds that are offered protection under Policy 6.

## **2. HERITAGE ASSET TYPES**

2.1 Heritage assets are categorised herein as one of four types:

- a. Listed buildings, also known as designated heritage assets;
- b. Non-listed buildings (which although not listed form part of the fabric and heritage of the neighbourhood area), also known as non-designated heritage assets;
- c. Sites (of archaeological and / or historical interest), including scheduled monuments;
- d. Finds (of archaeological and / or historical interest);

2.2 The manner in which each type is dealt with when considering planning matters is described in Policy 6 of the Saham Toney Neighbourhood Development Plan.

2.3 Details of listed and non-listed buildings are given in Section 4, Table 1, and are depicted on Policy Map 2 of the Saham Toney Neighbourhood Development Plan.

2.4 Details of sites and finds are given in Section 5, Table 2, and are depicted on Policy Map 3 of the Saham Toney Neighbourhood Development Plan.

## **3. DEFINITIONS, ABBREVIATIONS and USE OF THE REGISTER**

3.1 In Tables 1 and 2 NHE is an abbreviation for "Norfolk Heritage Explorer", which is an online resource published by Norfolk County Council providing more details about many of Norfolk's heritage assets. It is an extract from Norfolk County Council's Historic Environment Record. It can be found at <http://www.heritage.norfolk.gov.uk>, and by performing a search by parish, a user is able to find a list of all assets recorded by the service in the Saham Toney Neighbourhood Area (as of October 2017 there are 152 such records).

3.2 The Norfolk Historic Environment Record includes a description and where known, a map reference of an asset and in many cases an aerial photo showing its location and / or photos of the asset. Hence developers and others are recommended to use the Norfolk Historic Environment Record as an aid when reviewing if / how Policy 6 applies to a particular development site. Where Norfolk Historic Environment Record online records record an aerial map the exact location it shows takes precedence over the locations shown on Policy Maps 2 and 3 of Policy 6. Data in the Norfolk Historic Environment Record is not static and may be subject to change and enhancement during the life of the Neighbourhood Plan. This is because new discoveries are made and buildings may be reinterpreted, and the implementation of new nationally or locally derived guidance and policies can lead to reassessment of the significance of individual or groups of heritage assets.

3.3 A heritage asset is defined as a building, monument, site, place, area or landscape identified as having a degree of significance meriting consideration in planning decisions, because of its heritage interest.

3.4 Archaeological interest in a heritage asset is defined as when a building holds, or potentially may hold, evidence of past human activity worthy of expert investigation at some point. Heritage assets with archaeological interest are the primary source of evidence about the substance and evolution of places, and of the people and cultures that made them.

3.5 Historical interest in a heritage asset is defined as when a building or site illustrates important aspects of the nation's social, economic, cultural, or military history and/or has close historical associations with nationally important people. There should normally be some quality of interest in the physical fabric of an asset itself to justify the statutory protection afforded by listing.

3.6 Architectural interest in a heritage asset is defined as when a building has importance in its architectural design, decoration or craftsmanship.

3.7 Listed building is defined as a building which is for the time being included in a list compiled or approved by the Secretary of State. For the As prescribed by Law the following shall be treated as part of a listed building:

- a. any object or structure fixed to the building;
- b. any object or structure within the curtilage of the building which, although not fixed to the building, forms part of the land and has done so since before 1st July 1948,

3.8 The 'communal view' of a heritage asset is defined as a view of the asset from a public road or other location accessible to the public.

3.9 The 'setting' of a heritage asset is defined as the surroundings in which a heritage asset is experienced. Its extent is not fixed and may change as the asset and its surroundings evolve. Elements of a setting may make a positive or negative contribution to the significance of an asset, may affect the ability to appreciate that significance or may be neutral."

3.10 A heritage asset 'site' is defined as a location where works of man or the combined works of nature and man of archaeological / historical interest have been found, and locations which are of outstanding universal value from the historical, aesthetic, ethnological or anthropological point of view.

3.11 A heritage asset 'find' is defined as items resulting from works of man or the combined works of nature and man, and which are of archaeological / historical interest.

3.14 Curtilage is defined as the land immediately surrounding a heritage asset building, including any closely associated buildings and structures, but excluding any associated open fields beyond, and also excluding any neighbouring buildings in different ownership to that of the heritage asset building.

3.15 Scheduled monument is as defined under the Ancient Monuments and Archaeological Areas Act 1979.
